Subject: Regarding Centrally Sponsored Scheme of Pre-Matric Scholarship to the children of those Engaged in Occupation involving Cleaning and Prone to Health Hazards:- Continuation of the Scheme from the year 2017-18 to 2019-20 with modifications.

Please find enclosed here with the letter No. 11014/04/2017-SCD-V dated 02.04.2018 received from the Pravin kumar Tripathi, Under Secretary, to the Government of India, Ministry of Social Justice and Empowerment, Shastri Bhawan New Delhi on the subject cited above.

In this context, it is to inform you that the Ministry of Social Justice and Empowerment, Government of India has decided to continue this Sponsored Scheme from the year 2017-18 to 2019-20 (co terminus with Fourteenth Finance Commission Cycle) with the following main modifications:

- (1) The Scholarship may also cover the children whose parents are engaged in hazardous cleaning as defined in Section 2(i)(d) of Manual Scavenger's Act 2013.
- (2) The rate of Scholarship for Day Scholars stands enhanced from 110.00 to Rs 225.00 per month with effect from the new Academic session 2018-19.
- (3) National Safai Karamcharis Finance and Development Corporation (NSKFDC) will be coordinating agency between Central Government and State/ UT Administrative for effective implementation of the scheme.
- (4) Use of Aadhaar as identifier under Section 7 of the Aadhaar (targeted Delivery of Financial and other Subsidies, Benefits and Services) Act 2016. Where the beneficiary does not have Aadhaar ID, the individual shall be offered an alternate and viable means of identification.

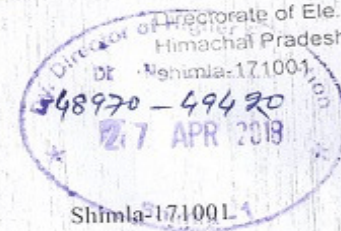
In view of the above, you are therefore, requested to bring this information to all the Principals/ Headmaster/BEOs working under your control and also direct them to take further necessary action in the matter.
