In compliance to the Director of Higher Education office letter No EDN-H (21)B(15) 47/2017-All Types Training- Dated 22-06-2017, on the subject cited as above.

The Department always tries to sponsor the teachers to various training programmes in routine manner. There are two Training Institutions responsible for imparting trainings to employees of Education Department. The SCERT, Solan has been assigned the training job for six Districts (Bilaspur, Kinnaur, Solan, ***SHIMLA***, Sirmaur and Una) and GCTE Dharmshala for rest of Districts. Further at the State level Himachal Pradesh Institute of Public Administration, Fairlawn's Shimla (HIPA) organize various training programmes for all departments.

It is the matter of great regret that, in spite of the orders from Directorate, this office and Principal SCERT Solan, that the allotted slot of teachers, so deputed for different training programmes do not take any interest or head of the institution failed to comply the orders of higher authorities, consequently, the **slot allotted to District Shimla goes in vain**. Sometimes some deputed teachers refuse to attend the training programmes on one or other pretext, shows the laxity of the teacher and is unbecoming on the part of teacher and violation of CCS Rules, 1965.

The department deposes the teachers for training programmes with a motive that he/she will be equipped with the modern teaching techniques and make aware of the frequent changes in his/her subject that the students can be benefitted.

Therefore, **it is directed that in future the teacher deputed for a training programme must attend the same otherwise he/she shall be liable for disciplinary action for which he/she shall be responsible.**

Further, you are also directed to supply the feedback report o training programmes conducted by SCERT, CCRT on proforma enclosed within in two days positively through Email or fax, followed by hard copy by post.
