As you are aware that HP State Legal Services Authority has adopted the project of sensitization of school children about importance of Forest as well as Environment issues especially Afforestation, Plastic & Garbage disposal issues during 2014-15, AND 2015-16 and **has been decided to continue the Afforestation Project in the Year 2016-17 also** Afforestation Project will be executed in the following manner :

- Fresh Plantation will be done by the students of **7th Standards onwards**
- The students of **7th to 12th** standard shall also maintain the old sites which include **re-plantation where survival rate of plantation carried out in previous years is less than 90%**
- New sites for the **students shall be near the school**. While carrying out plantation in school compounds, the same will be done keeping in view the area required for expansion of school building and ground.
- The Sites shall be identified by the **Forest Department** and also saplings will be planted on such identified sites. Pits will be made by the Forest Department.
- You are directed to coordinate with concerned Forest Department/office /Range Office accordingly.


