6.	Last Date of submission of the Duly Attested Verified Candidate Lists by the Govt. Colleges, within State, to this Directorate. (The Govt. Colleges need to retain the Printed Hard Copies, at their end).	15 th January, 2018

Last Date of submission of the Duly Attested Verified Candidate Lists & Printed Application Forms by the Private Colleges & Govt. / Private Universities / Professional / Technical Institutes, etc., within state, and Out of State Institutions, to this Directorate. 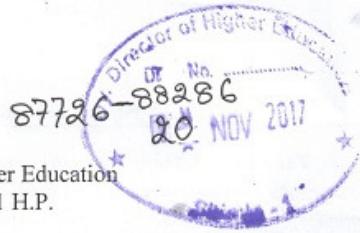


