Terms & Conditions: -

5. Before relieving the promotee(s) to join his/her new place of posting, it must be ensured that the concerned promotee(s) must have completed FIVE YEARS OF REGULAR SERVICE AS PEON.
6. DDOs of the concerned institutions are directed to allow the promotee(s) to join in the school only if the post is vacant and send his/her joining to this office immediately.
7. In case there is any MISTAKE in the particulars of the promotee(s), the clarification may be sought directly from the undersigned and the promotee(s) be relieved only thereafter.
8. Before relieving the promotee(s) to join his/her new place of posting on promotion it may be ensured that NO DEPARTMENTAL ENQUIRY/ PROCEEDING AND VIGILANCE CASE is pending against the said promotee(s).
