
You are therefore, requested to supply the desired information directly to the applicant within the stipulated period as per provisions of RTI Act under intimation to this office.

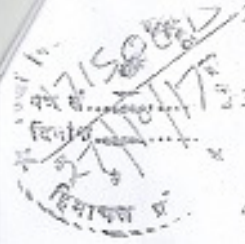
