**ORDER**

In pursuant to the decision taken by the HP Government, conveyed by the Department of Personnel vide letter No. Per(AP-B) F(1)1/2016, dated: 30.11.2018, that:- **Part Time Workers, including Part-Time Water Carriers of Education department Completing 8 years of continuous service as on 31.03.2018 and 30.09.2018 respectively in all government departments will be converted to daily wager** ” duly conveyed by the Worthy Director of Higher Education, HP, on 07.12.2018, vide endorsement No. EDN-HE(1)B(6)-01/2016-Regul. and on the recommendations of departmental promotion committee, the following Part Time Workers (Part Time Water Carriers/Sweepers) who have completed 8 years of continuous services as on 31.03.2018 and 30.09.2018 are hereby converted as Water Carrier-cum-Peon on Daily Waged Basis with immediate effect subject to the fulfillment of the following terms & conditions as per rates approved by the Government time to time.

**Terms and Conditions: -**

1. The candidate will have to produce a medical fitness certificate from the CMO/MO of the illaqua concerned.
2. The candidate will have to furnish a declaration to this effect that if he/ she is not married/married and having one living spouse.
3. For the determination of date of birth of the candidate concerned, criterion as laid down in Rule 7.1 of HPFR Vol-I shall be observed.
4. The candidate will have to give in writing whether he / she was never convicted by any Court of Law, if, so the particulars of the offence and punishment imposed be mentioned, if, failing to disclose the facts will render him/ her liable to withdraw his/ her conversion as and when facts come to the notice of department.
5. The candidate will have to take an oath of allegiance/ faithfulness to the Constitution of India. If information/ documents supplied by the candidate is found to be incorrect/ false at later stage, in such event conversion of the candidate on daily wages basis is liable to be withdrawn.
6. If the offer of conversion on daily wages basis is acceptable to the candidate, he/ she should report to his/ her duty within 15 days from the issue of these orders, failing which above orders shall deemed to be withdrawn automatically. No specific orders reference to withdrawal of conversion will be issued separately to this effect.
7. Part-time Class-IV workers after completing eight years of continuous service as on 31.03.2018 and 30.09.2018 will only be made daily wagers. Posts vacated by such Part Time Workers shall stand abolished.
