

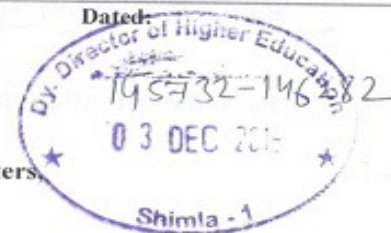

This is in reference to the Director of Higher Education Himachal Pradesh office letter No. EDN-HE (21) F (9)-07/2018—Drug Abuse, Dated 28-11-2018.

In this context, I am directed to refer above mentioned letter and to say that as per the meeting on Drug Abuse was held on dated 07-08-2018 under the chairmanship of Chief Secretary to the Government of Himachal Pradesh. The Secretary Education to the Government of Himachal Pradesh has apprised that ;

- Talk against drug abuse has been started in the School during morning assembly.
- Short play on drug abuse is being organised shortly at
- District Level Marathon would be organized shortly.
- Buddy system, which has been introduced in Punjab, will be studied for implementation in Himachal Pradesh
- A skit is being launched from 2<sup>nd</sup> October.

Therefore, you are hereby, directed to act immediately without any further delay on above mentioned points and also act against all the violations of section 4& 6 of the COTPA. If there is a shop selling any tobacco products within 100 yards of any educational institutions, then responsibility to act immediately as specified in the COTPA lies with the Head of Institution? They can seek the help of the local police officer of the rank of Sub-inspector & above for taking further necessary action. They may also refer to the "law Enforcer's Guidelines" released by MOHFW of Government of India. All the orders/ instructions against the violations of section 4& 6 of COTPA shall be maintained / obeyed in letter & spirit.

Further, you are also directed to supply the action taken report by you against all violations of section 4 & 6 of the COTPA to this office within week so that the Higher authorities can be apprised in the matter accordingly. Delay in supplying the information Head of institution and dealing assistant will be responsible and action as warranted under CC/CCA Rules will be initiated against the defaulters.
