In compliance with the Director of Higher Education, Himachal Pradesh office letter No. EDN-HE(21)F(9)-07/2019—Drug, Dated 11-06-2019.

As you are very well aware about the fact that issue of Drug abuse (Drug Consumption & Addiction) has become a matter of major concern in recent years for the society and the nation, as the number of youngsters getting addicted to drugs. The issue of supply of illegal drugs and abuse of legal drugs is emerging as a major problem in our State also. It is creating health challenges especially for young generation and school going children. The fight against Drug Abuse is one of the agenda of the State Government and Education Department has to play a crucial role in this endeavour. The problem of Drug Abuse can be solved by awareness, prevention, incentives and support efforts. Every Section of the society will have to come forward to defeat this dreaded problem. The State Government is quite serious about solving the problem of Drug Abuse and has also taken several initiatives. The Education Department has also been directed to keep on carrying out an aggressive campaign against Drug Abuse.

Therefore, all educational Institutions Govt./ Private are hereby once again directed to keep on carrying out an aggressive campaign against Drug Abuse by organizing various activities so as to sensitize the students and the society about ill effects of drug abuse. The activities are as follows:

Essay writing, Paintings/Poster making, Slogan writing, group discussion, Debate, declamation, Skits/Plays, Special Talks/Lectures or seminars on the subject of ill effects of Drug abuse by Police, Doctors, Teachers etc. It is also directed by that the all heads of the schools Government as well as Private must adhere strictly to the instructions as under:

- Compulsory hold meetings of Anti-Drug abuse Vigilance Committee in every School lat least once in a month and make sure to involve SMC/Parents/PTAs in the meetings as it not only improves students behaviours but also positively affects students achievement.
- Talk against drug abuse and some other national issues prevailing in country like illiteracy, Education System, Basic Hygiene, Moral Values, Healthcare System, Pollution, Women's Safety etc. in the schools during morning assembly should be a regular features. Special talks should be organised every month on ill-effects of Drug Abuse in the schools.
- 3. Medical experts/Doctors under Rashtriya Sawasthya Karyakram (RBSK) can also be invited in Anti Drug abuse Vigilance Committee Meetings so as to Identify Symptoms, Behavioural Problems etc. for early intervention and promptly referring students to health care professional for assessment and intervention to raise awareness about health related issues and rehabilitation services related to Drug Abuse that are available within the community to aid student, Family and school.

Any lackadaisical approach in this matter will be viewed seriously and action as warranted under rules will be initiated against the defaulters.
