Sir/Madam

In continuation of this Directorate letter of even No. dated 12-05-2016, it is once again re-iterated that the Government of Himachal Pradesh has decided to roll over the new Scheme "Mukhya Mantri State Health Care Scheme" for the categories which are not covered under "Rashtriya Swasthya Bima Yojna" (RSBY) or any other medical reimbursement scheme. Under this new scheme, following categories will be covered.

1. Sr. Citizens (more than 80 years of age) (only more than 80 years of age dependents will be covered)
2. Ekal Naaris (Widows, Divorced, Deserted & Unmarried)
3. Daily Wage Workers (Government, Autonomous Bodies, Societies, Boards and Corporations)
4. Part Time Workers (Government, Autonomous Bodies, Societies, Boards and Corporations)
5. Mid Day Meal Workers
6. Anganwari Workers
7. Anganwari Helpers
8. Contractual employees (Government, Autonomous Bodies, Societies, Boards and Corporations)
9. Persons with more than 70% disability

- Major Features of this Scheme include coverage of Rs.30000/- under Basic package and Rs.175000/- under Critical care Package per family on floater basis in case of hospitalization. The Scheme is completely State funded and only Rs.30/- will be collected from the beneficiary at the time of enrolment as registration fees. The smart card issued will be valid for 5 years; however the cards are needed to be renewed after 3 years.
- The State Government has selected M/s Rural Technology Services Pvt.Ltd. Pitampura, New Delhi through tender process to implement the Scheme in the State.
- The M/s RTS will be responsible for enrolment of beneficiaries and claim data processing. All the hospitals which are empanelled under RSBY are eligible to provide benefits to new beneficiaries.

- The beneficiary has to come with four family members (dependents) for enrolment and getting the smart card etc. For which an enrolment & declaration form may be uploaded on website [www.nrhmp.gov.in](http://www.nrhmp.gov.in). The form can be downloaded from the link given below.

- The Concerned Department will verify the form and beneficiary will submit it at enrolment station and get his smart card immediately for which the representatives of company (kit operator) will capture the photograph and biometric information of all the family including beneficiary.

In view of the above, you are, therefore, directed to further direct all the employees (mentioned above) under your control to get the smart card prepared immediately by visiting the enrolment station. For more information, the beneficiary can contact at toll free number 1800-301-00334. In this context, you are further requested to give wide publicity (through print media and electronic media) about this scheme among all the above-mentioned employees working in the Department of Education for getting the benefits of this scheme and they may also be encouraged to adopt this scheme voluntarily. Action taken in this regard may be intimated to this Directorate.
