**Conditions: -**

1. The above official(s) will join their place of posting on or before 30.06.2019, failing which the regularisation orders shall be deemed to have been withdrawn automatically for next one year. No specific orders with reference to withdrawal of regularisation will be issued separately.
2. Before relieving the official(s) for joining at the new place of posting on regularisation, it must be ensured that no departmental inquiry/vigilance case is initiated/pending against the said regularized employee.
3. After regularization, the original post of concerned daily wager/ contingent paid workers shall be abolished.

4. In case vacancy is not available/created so far, the regularized employee (s) may not be permitted to join the station and the case may be send to this office immediately for further orders.
5. In case of any error/omission is detected in these regularisation orders at later stage, the same is liable to be corrected and such regularisation orders will be withdrawn and the regularized employee (s) shall have no claim for the regularisation.
6. Concerned DDOs are directed not to allow any regularised employee to join in the school without checking his/her relieving from previous institution only if the post is lying vacant and send joining report to this office immediately.
7. In case there is any mistake in the particulars of the regularized employees, the clarification may be sought directly from the undersigned and the regularized employee be relieved only thereafter.
8. The above regularisation orders are subject to the review due to any consequential administrative reasons.

## TERMS AND CONDITIONS

1. The candidate will have to join his/her place of posting within FIFTEEN DAYS from the issuance of these orders, failing which his/her appointment/regularisation orders stands automatically withdrawn. No specific orders will be issued to this effect separately.
2. The concerned candidate will have to produce a Medical fitness certificate from Medical Officer of the illaqua/Registered Medical Practitioner.
3. The concerned candidate shall have to submit a declaration to this effect that he/she is not a dismissed employee of any Govt./Semi Govt. Deptt.
4. If any declaration submitted/furnished by the candidate found to be false at any stage or he/she has concealed willfully any information, he/she shall be liable to be removed from service and to such action deemed necessary.
5. The concerned candidate must have to produce the attested copies of his/her date of birth and educational qualification certificate.
6. Concerned candidate shall have to take oath of allegiance of faithfulness to the constitution of India in the prescribed proforma.
7. Concerned candidate shall have to produce his/her certificate of being Bonafide resident of Himachal Pradesh from competent authority not below the rank of Magistrate 1<sup>st</sup> Class.
8. Concerned candidate shall have to serve the department any where in Shimla District.
9. Concerned candidate shall have to produce fresh character certificate from a Gazetted Officer to whom he/she is known for the last three years.
10. Concerned candidate shall have to give in written that he/she was never convicted by a criminal court and if so, particulars of the offence and the punishment imposed be stated, failing to disclose the facts will render her liable for removal from service beside other action deemed fit.
11. His/her services can be terminated at any time without giving any notice/reasons.
