
## PRESS RELEASE

As per Stipulated time Period given against Sr. No. 1 to 3, No extension will be granted in future. Failing which the whole responsibility will be of the concerned DDHEs and Head of the Institutions

### IMPORTANT INSTRUCTIONS:-

- All Head of the Institutions/DDHEs are directed to ensure the online verification of all eligible students within a stipulated time period who were applied on HP ePass Portal under the State and Central Sponsored Scholarship Schemes, for the year 2018-19, otherwise Head of Institutions within and out of state are fully responsible for the non-verification (online) of eligible students application form and lapse of scholarship amount.
- After due dates, no permission will be given/provide to the Institutions within and outside of State for online verification, at any circumstances; therefore all Head of Institutions/DDHEs are direction to make sure to do the online verification of eligible students within a stipulated time period.
- All Head of the Govt./ Govt.-Aided / Private Affiliated Institutions are directed to ensure:-
  - The student bank account no. should be linked with students Aadhaar Number and only one bank account number will be acceptable for one application form.
  - 75 % Attendance of the students.
  - Parents Income Certificate, issued by the Executive Magistrate of conerend area.
  - The Hard copy will not be submitted for the year 2018-19.
  - Group Photo of Monitoring Committee duly signed by Committee.
  - All Head of Institutions are directed to constitute the Monitoring Committee who was not constituted till date.
  - An undertaking to be furnished by the Private Institutions must be on Judicial Paper not below Rs.100/- duly signed and attested by the Executive Magistrate.
  - No student show pending for verification at Institution Level. If any student does not provide the required documents in stipulated time period then reject permanently as such type of cases at your own level.
- All Deputy Directors of Higher Education, HP is directed to send the budget demands to this DHE, HP Shimla under the Pre-Matric OBC Scholarship Scheme from 1<sup>st</sup> to 8<sup>th</sup> class (offline mode), as per revised guidelines of Govt. of India for the year 2018-19 upto 31-05-2019.


