It is to inform you that the Ministry of Minority Affairs, Government of India, New Delhi has opened date for receipt of online application from students under Pre-Matric Minority Community Scholarship Scheme from 1<sup>st</sup> June 2017 to 31<sup>st</sup> August, 2017 for fresh scholarship and for renewal scholarship up to 31<sup>st</sup> July 2017. Under this scheme the scholarship will be awarded to the meritorious students from notified minority communities VIZ Muslims, Christians, Sikhs, Buddhists Parsis and Jains studies in a Government or private schools from classes 1<sup>st</sup> to 10<sup>th</sup>.

You are therefore requested to bring the above instructions of GOI to the notice of all the head of institutions for giving wide publicity regarding of date, in the public domain. In the morning assembly, displaying a notice in this regard on the school notice-board, on the Panchayat and Mahila Mandal office's notice boards and in local news paper so that all the eligible students could avail the benefit of this scholarship scheme. This may also be announced daily in the morning assembly that the bank account of the students applying for the aforesaid scholarship must be linked with their Aadhaar number so that their scholarship could easily be released in their bank account through DBT mode and from the year 2016-17 the National Scholarship Portal has started only online application for classes under this scheme will be accepted and no request for offline applications will be accepted by the National Scholarship Portal. The Aadhaar No. will be mandatory for this scheme otherwise no application will be accepted by the portal. This scheme will be done through the National Scholarship Portal (NSP) of the Government of India, under URL [www.scholarship.gov.in](http://www.scholarship.gov.in). A link to the site is also made available in the website of the Ministry i.e. [www.minorityaffairs.gov.in](http://www.minorityaffairs.gov.in). The detailed guidelines of the scholarship is available on the National Scholarship Portal (NSP).
